4a (Code:) (Expenses \$ 656,754. including grants of \$) (Revenue \$ 0.) Meals On Wheels Atlanta enables frail and/or homebound seniors to remain in their homes through nutrition and visits. More than 100,000 meals were delivered by volunteers and staff in 2009-10. Nine different meals types are offered to meet specialized needs and urgent meals are provided for seniors in desperate need of immediate assistance.

4b (Code:) (Expenses \$ 713,007. including grants of \$) (Revenue \$ 9,475.) Home Repair Services enable senior homeowners to remain independent through maintenance, repairs and modifications that they need. Volunteers provide minor repairs and maintenance, while staff and contractors perform moderate and major repairs.

4c (Code:) (Expenses \$ 526,487. including grants of \$) (Revenue \$ 2,375.) Neighborhood Senior Centers provide a "home away from home" for semi-active seniors who seek socialization and wellness support. Centers are operated in cooperation with Fulton County Human Services and provide trips, wellness classes, crafts, fitness, nutrition, arts, learning opportunities, advocacy, disease management, etc.
