Meal Services provides more than 160,000 nutritious meals to approximately 689 Atlanta seniors annually. These seniors are unable to prepare or afford the nutrition they need due to extenuating circumstances such as disability or poverty. We offer eight different meal types to meet specialized health requirements. Urgent meals and pantry items are provided for seniors in desperate need of assistance. Meals are delivered by staff and volunteers which decreases isolation for many of our senior clients.

4b (Code:) (Expenses \$ 865,137. including grants of \$) (Revenue \$ 15,904.)
Home Repair Services provides more than 1700 home repairs to approximately 230 clients annually. Home Repair Services enable senior homeowners to remain independent through necessary maintenance, repairs and modifications. Volunteers provide minor repairs and maintenance, while staff and contractors perform moderate and major repairs.

Meals On Wheels Atlanta operates and manages seven Fulton County Neighborhood Senior Centers where we serve more than 500 clients annually. Our senior centers provide a "home away from home" for semi-active seniors who seek socialization and wellness support. Centers provide trips, wellness classes, crafts, fitness, nutrition, arts, learning opportunities, advocacy, disease management, etc.
